00418. PUBLIC PARTICPATION

A member of the public asked

a) With reference to the role the discussions on a possible officer to project manage the Climate Action Plan, why the council is offering a low wage for a post that pays a national average of £39,000 per annum when Rother District Council and East Sussex County Council are the statutory bodies for environment policies. The council has not made any decisions on such a post. Initial exploratory discussions suggested that the role might not need professional climate qualifications. The role could be a project delivery role, working in conjunction with the statutory bodies. Initial research on similar parish and town roles showed that the salary may be around £25,000 per annum. No decisions have been made.

b) If an environmentalist should be employed by Rother District Council or East Sussex County Council.

c) Does the £25,000 salary suggested for this role include all costs, such as National Insurance, pension, car and out of pocket expenses? The discussion with reference to on-costs has not yet taken place, as the role has not been fully explored.

d) Who will this person's line manager be and what will their remit be? Will the committee be their line manager? None of this has been discussed as yet.

- v. To provide compensation for the losses and costs suffered because of the calamitous failures of Southern Water.
