## 3. Funding

Should transfer of these assets take place the cost of maintenance and future repairs and replacement would be the responsibility of the town council. Effectively, a change of ownership would take place and the town council would be legally responsible.

The town council could collect funding towards the grounds maintenance, bus shelters and museum through special expenses.

Public conveniences funding would need to be considered as a separate matter.

# 4. Next Steps

The Asset Transfer Committee is meeting to review the costs of maintenance of the assets listed and make recommendations to full council on how to proceed.

The town council is not obliged to accept transfer of any of these assets, however with the financial strains on local councils means that the district council may have to reduce services in order to maintain financial stability. This would have a subsequent effect on the maintenance of these assets.
