Going forward there could be an annual plan; you could maybe encourage businesses to come forward. In relation to this particular event, White Label have historically pulled in between 5 and 10 thousand people into Bexhill. That footfall has a huge effect on our economy.

Representative from White Label Events CIC, in regard to Roger Crouch and his directorship, this was purely administrative and will hopefully be sorted soon so he can be reinstated. I want to reassure you that every penny goes into the event, and some money even comes from myself, Rogers' and others pockets. Theres no charity donations or anything. It really does just go into making the event the best that we can. Roger has received two calls this week informing him that we've got a coach of people coming down from Hempstead who are part of an 80's fan club. It definitely brings tourism into the town.
