COMMUNITY-INFRASTRUCTURE LEVY FUNDS FOR COMMUNITY GROUPS POLICY

Proposed Policy for Bexhill-on-Sea Town Council: Allocation of CIL Funds to Community Groups

1. Objective

- 1.1 To provide a transparent framework for the allocation of CIL funds to community groups, ensuring that funded projects contribute to the development of local infrastructure and address the demands placed on Bexhill-on-Sea by new developments.

2. Eligibility Criteria

- 2.1 Community groups seeking CIL funding must:
 - a) Be properly constituted not-for-profit organisations, charities, or community interest companies.
 - b) Demonstrate that the proposed project aligns with the definition of infrastructure as per the CIL Regulations, which includes:
 - Roads and other transport facilities
 - Flood defences
 - Schools and other educational facilities
 - Medical facilities
 - Sporting and recreational facilities
 - Open spaces
 - c) Show evidence of community support and engagement.
 - d) Provide a clear plan detailing project objectives, timelines, and anticipated outcomes.
 - e) Demonstrate financial sustainability, including efforts to secure match funding where possible.
 - f) Proof of fund-raising initiatives.

3. Process for allocation of funding

3.1 Ensure your project meets the criteria set in the CIL Policy (it is recommended that contact is made with the Clerk in the first instance).

3.2 Projects will be prioritised using the following categories:

- Beneficiaries
- Benefit classification
- Cost
- Infrastructure category
- Partner (If appropriate)
- Status

3.3 Complete CIL Funding Application form

3.4 The application if eligible, will be considered by Full Council.

A project evaluation form will be completed by the Council.
Results will be published and applicants will be notified of the outcome of the meeting.

Representatives of the application are encouraged to attend this meeting.

Projects that are accepted for funding will be added to the list of future projects.

4. Funding Conditions

4.1 Funds must be used solely for the approved project.

4.2 Projects should commence within a specified timeframe post-approval.

4.3 Regular progress reports must be submitted to the Town Council.

4.4 Any unspent funds must be returned if not used within the agreed period.

4.5 Effect to secure match funding.

5. Monitoring and Reporting

- 5.1 The Town Council will monitor funded projects to ensure compliance with the terms.
- 5.2 An annual report detailing CIL fund allocations and project outcomes will be published to maintain transparency.

6. CIL Community Fund Allocation

- 6.1 The Council will allocate 50% of the Total Community Infrastructure Levy balance for CIL Community Fund.

7. Prioritising Projects

- 7.1 Applicants requesting CIL funding should read the guidance notes and complete an application form which will be processed and evaluated and, if successful, granted as and when there is sufficient funding assessed by Full Council/or FAC.
- 7.2 The projects will be prioritised using the following categories (in alphabetical order):
 - Beneficiaries
 - Benefit classification
 - Cost
 - Infrastructure Category
 - Partner (If appropriate)
 - Status

Guidance for Use of CIL Community Fund

The community Infrastructure Levy (CIL) is a levy which a charging authority (in our case Rother District Council – RDC) may charge on new developments to fund infrastructure such as schools, transport, parks, open spaces and other community facilities, which is required to support new housing and economic development in the district.

Under CIL regulations 15% of CIL receipts for development in a with a Parish or Town Council must be passed onto the Parish or Town Council where the development has taken place.

Priority for CIL funding will be given to infrastructure that is needed as a result of the development that has generated the CIL payment.

Bexhill-on-Sea Town Council holds CIL funds of which XX% is for allocation to CIL Community Fund.

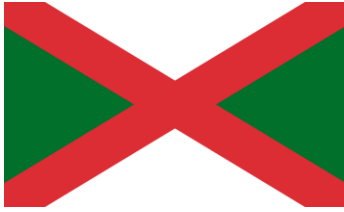

COMMUNITY-INFRASTRUCTURE LEVY FUNDS GUIDE

Introduction

The community Infrastructure Levy (CIL) is a levy which a charging authority (in our case Rother District Council – RDC) may charge on new developments to fund infrastructure such as schools, transport, parks, open spaces and other community facilities, which is required to support new housing and economic development in the district.

What is CIL?

Under CIL regulations 15% of CIL receipts for development in an with a Parish or Town Council must be passed onto the Parish or Town Council where the development has taken place.

Where a Parish or Town Council has adopted a Neighbourhood Plan the CIL receipt will increase to 25% of CIL receipts for that Town or Parish Council will be passed on.

CIL is paid by RDC twice a year if it is due, April/May and October/November.

Please note – If the Town Council does not spend its levy share within five years of receipt or does not spend it on initiatives that support development of the area, Rother District Council may require Bexhill-on-Sea Town Council to repay some or all of those funds (regulation 59E).

At the end of each financial year Rother District Council request the Town Council to complete the CIL Annual Monitoring Statement detailing CIL monies received and spent, including any specific had been spent or planned for future spend.

The CIL Annual Monitoring statement is published on Rother District Council website and on Bexhill-on-Sea Town Council website.

It must be relevant to the development of that area.

The definition of infrastructure as per the CIL Regulations, which includes:

- 14. Roads and other transport facilities
- 15. Flood defences
- 16. Schools and other educational facilities
- 17. Medical facilities

18. Sporting and recreational facilities

19. Open spaces

By adopting this policy, Bexhill-on-Sea Town Council can ensure that CIL funds are allocated effectively to community groups, fostering infrastructure development that meets the evolving needs of the community.
